### **Message from the Community Recovery Coordinator**

As the River Murray flood waters continue to recede we are increasingly turning our attention to the important work of clean up and recovery. Communities have been impacted in various ways but the State Government along with local governments are working tirelessly to ensure stakeholders are front and centre of this response. While river communities are resilient by nature the reality is a flood event of this magnitude has not occurred in South Australia for decades.

Preparatory work with the recovery team and various response agencies has been underway since the beginning of this generational event. While there is understandable angst in the community about the pace of recovery, every effort is being made to ensure safe and best-practice methods are followed. I

encourage people to remain patient and know that efforts are being made at a considerable pace. On a personal level I have made it a key priority to consult widely across the many regions impacted to ensure governments of all levels are provided with an accurate reflection of life on the ground.

I am also working with the Department of Environment and Water and the recovery team to assist communities, primary producers, shack owners, businesses and other impacted stakeholders deal with the time-sensitive issue of dewatering. These agencies will work with those impacted around floodplains to recover as soon as possible.

In the coming weeks and months there will be several opportunities for residents to participate in recovery community meetings. I encourage you to take up this offer to share your views and help tailor the response to your needs.

### Outlining the flood recovery process

A state recovery effort of this magnitude requires a whole of government, whole of community approach. The Department of the Premier and Cabinet is coordinating the recovery program. A series of working groups have been established such as a First Nations Working Group, as well as others that focus on time sensitive tasks such as reconnecting power to properties and repairing the transport network. Various interest groups including shack owners and the agricultural sector feed key information to Alex Zimmermann, the Community Recovery Coordinator, who acts as a link between community, government departments and agencies.

Non-government organisations, volunteers and support agencies are also a key pillar of the recovery process and will continue to support river communities as water levels return to normal.

### **Recovery priorities**

Local councils and communities are increasingly turning their attention to recovery efforts. There are several priorities being addressed including:

### Dewatering & levees in the Lower Murray region

With the River Murray flood situation now moving into the recovery phase, the re-establishment of the levee network and dewatering process is the highest priority for producers in the Lower Murray region.

Whilst the planning process is already underway, recovery of the Lower Murray Reclaimed Irrigation Area will be a complex process to assess and undertake the works required.

It is recognised that each irrigation trust area has been impacted differently and as a result, the Department for Environment and Water (DEW) is meeting with impacted landholders and Trusts to determine their thoughts on what works may be required in the short term to repair the levee embankments. Once it is deemed safe to do so, DEW will then undertake on-ground inspections.

Until these inspections are completed, it is not possible to predict the exact nature of the works required, or when they will be completed. In the meantime, drones are being used to monitor water levels around government-owned levees and undertake initial inspections.

Dewatering will also be a long-term recovery activity and with waters still receding, it is still too difficult to determine the timeframe and what will be required for dewatering. However, the Department of Primary Industries and Regions (PIRSA) is leading planning activities during this period to ensure that there are no significant delays once the required initial levee repair work is complete.

PIRSA will also work with industry and other State Government agencies to undertake an engagement process with Irrigation Trusts in the Lower Murray to determine the broader recovery requirements for each Trust. This will provide an opportunity for landholders impacted in this area to discuss local issues and options for de-watering.

Primary producers impacted by the River Murray flood are encouraged to access the Primary Producer Recovery Grants and the Primary Production Irrigation Grant along with other services. Information is available through the <u>PIRSA website</u> or calling 1800 931 314.

#### Access

The Department for Infrastructure and Transport is prioritising necessary repairs to State Government managed roads, including ferry access roads, as the water further recedes and is working closely with local councils to ensure locally managed roads can be re-opened as soon as possible.

Road users are reminded to obey all road signage, always drive to the conditions and never attempt to travel through flood waters. For the latest traffic information, including road closures and detours, please visit <a href="mailto:traffic.sa.gov.au">traffic.sa.gov.au</a>.

### Fight the bite

The stock of available Japanese encephalitis virus (JEV) vaccine in Australia, including South Australia, remains limited.

On Monday, 13 February the Chief Public Health Officer, Professor Nicola Spurrier, announced that the eligibility criteria will be expanded to people with a primary residence in the Local Government Areas of:

- Alexandrina Council
- Berri Barmera
- Mid Murray Council
- District Council of Loxton Waikerie
- Coorong District Council
- Rural City of Murray Bridge
- Southern Mallee
- Renmark Paringa Council
- Karoonda East Murray District Council
- Unincorporated areas next to the Murray River within the postcodes 5330, 5341, 5342, 5343, 5344 and 5345

People who own a secondary residence affected by the River Murray flood event, including dependents and other immediate family who reside with the owners, are eligible. There is insufficient vaccine to provide to people (family or friends) outside of those in the eligibility criteria who are considering entering the area to assist with flood clean up.

Those who were eligible under the previous requirements continue to be eligible. Click <u>here</u> for details.

It is important that everyone protects themselves against mosquito bites, even if vaccinated against JEV, as there are other mosquito borne viruses able to be transmitted in SA for which there is no vaccine. # Statement from Professor Ian Overton Chief Executive of Green Industries SA

If your property has been impacted by flood water, please register for a free assessment and free waste and debris disposal. Assessments will look at the safety of the structure and hazards like asbestos and mould. The assessment will belong to the property owner, and it's up to the owner to decide who to share that assessment with. For anyone who is insured, speak to your insurance company and follow their advice. We still need people to register for waste and debris removal to access services and benefits from the government funded clean up.

No one wants to demolish a property that doesn't need to be demolished. That's not the focus of our work in the clean up and recovery. Our focus is to clean up the debris and get the River Murray region back to business as usual for residents, shack owners, farmers and local businesses.

My staff are working tirelessly planning services and programs and mapping the logistics of how we help the community recover from the flood impact.

Safety is of paramount importance. Hazards like asbestos, black mould and unsafe structures can put people's health at risk. Green Industries SA will cover all the costs for the removal and disposal of asbestos and debris affected by black mould.
